Grants are not made to individuals or organisations in UK. The majority of funds are focussed on Fundatia Emanuel Betania, a not-for-profit company registered in Teius, Romania. There is no policy to invest funds. Funds not required for immediate use are held in an HSBC savings account. During 2017 all but one money transfers to Romania were carried out by SEPA in euros, which minimises the transaction charge. The trustees are personally responsible for their own travel and administration costs. All volunteers are required to be self-funding. The charity's administration and transport costs are met by the trustees

Section D	Achievements and performance
Summary of the main achievements of the charity during the year	At the AGM in April 2017 the Trustees agreed to wind down the work of the charity in 2017/8 to be in a position to close the charity registration in 2019; unless another group, or individuals, come forward to take over. A consequence of this decision was the need to spend a large part of the charity reserves during 2017.
	During 2017 the bulk of our financial support continued to go to Fundatia Emanuel Betania in Teius. Material aid was focussed on projects in other places, particularly Berindei in the south of Romania.
	During 2017 we constructed a new entrance and toilet block at the hall in Teius; and commenced work on obtaining a fire certificate and sanitary certificate for its use as a public building. The focus of activities in Teius is being shifted from those we run ourselves, to activities run by other groups. A Foundation from Targu-Mures led a weekly meeting for mothers in Teius, during the second half of the year.
	Summer holiday camps were sponsored for 70 children from Cornesti and Sona. 330 T-shirts were donated to children and young adult camps from Timisoara.
	Approximately 80 Christmas presents were sent for poor children in the village of Cornesti. In Autumn 2017 we received a large quantity of children's clothes and schoolbags from Rowlinson Knitwear, and a large quantity of nutrient snack bars from Wholebake. These formed part of our wider Christmas program in Timisoara, Berindei, Draganesti-Olt, Cornesti, Adamus, Teius and Aiud.
	Private sponsors were found to help a number of university students.
	We have a new contact for visiting prisoners in Aiud gaol, and their families in the community.
	We received quantities of medical dressings which were sent to Dr Alina Nistor in Berindei. We extended the sponsorship of a nurse in Berindei by two more years to provide home visits for the elderly (year 4 of 5).
	Trustee News: Martin Woodhall visited Romania three times during the year to check on the progress of projects.
