**Activities in relation to advancement of education:**

Supporting the teachers of the Sunday-School in Timisoara with clothing, and art materials. School materials via Christmas boxes. Supporting the schools in Berindei, Cornesti, Sona and Adamus with clothing and equipment such as computers, consumables and sports equipment.

**Activities in relation to advancement of religion:**

Supporting various activities in Teius, Cornesti, Timisoara and Berindei – encourage children and adults to attend their local church, singing of Christian music, evangelistic meetings and bible study.

**Activities in relation to relief of poverty:**

Provision of food, second hand and new clothing. Humanitarian relief in Berindei. Clothing for the prisoners in Aiud gaol. Sponsorship of a nurse for home visits to the elderly in Berindei.

**Activities in relation to facilities for recreation:**

Annual program of holiday camps and clubs for children from Cornesti and Timisoara – by sponsorship of children and/or leadership teams. Provision of sports equipment. Construction of Youth Hall in Teius for sport, music and drama.

The current policy on grant making is that all grants are made direct to Romania. Grants are not made to individuals or organisations in UK. The majority of funds are focussed on Fundatia Emanuel Betania, a not-for-profit company registered in Teius, Romania.

There is no policy to invest funds. Funds not required for immediate use are held in an HSBC savings account.

During 2018 all but one money transfers to Romania were carried out by SEPA in euros, which minimises the transaction charge.

The trustees are personally responsible for their own travel and administration costs. All volunteers are required to be self-funding. The charity's administration and transport costs are met by the trustees and do not appear in the payments section of the CC16a Accounts.

**Summary of the main achievements of the charity during the year**

At the AGM in April 2017 the Trustees agreed to wind down the work of the charity in 2017/8 to be in a position to close the charity registration in 2019; unless another group, or individuals, come forward to take over. A consequence of this decision was to continue to spend the charity reserves during 2018.

During 2018 the bulk of our financial support continued to go to Fundatia Emanuel Betania in Teius. Material aid was focussed on projects in other places.

Fundatia Emanuel Betania in Teius decided to become a kindergarten from September 2018, for which they have secured outside funding. This project will not be adopted by Reach 2 Romania, and our regular monthly funding for Teius is expected to cease in April 2019.

Summer holiday camps were sponsored for 70 children from Cornesti and Sona. 350 T-shirts were donated to children and young adult camps from Timisoara. Approximately 40 Christmas presents were sent for poor children in the village of Cornesti.

We received a large quantity of children's clothes from Rowlinson Knitwear, and a large quantity of nutrient snack bars from 9Brand. These formed part of our wider Christmas program in Timisoara, Berindei, Draganesti-Olt, Cornesti, Adamus, Sona, Teius and Aiud.

Private sponsors were found to help a number of university students, and young adults that had left an orphanage.

We continued to send clothes for prisoners in Aiud gaol, and their families in the community.

We continued to receive quantities of medical dressings which were sent to Dr Alina Nistor in Berindei. We completed the last year of sponsorship for a nurse in Berindei to provide home visits for the elderly (year 5 of 5). Dr Alina Nistor wishes to move to France during 2019, and our regular monthly funding for Berindei is expected to cease in April 2019.

Trustee News: Martin Woodhall visited Romania twice during the year to check on the progress of projects.
